

## Petroleum and Explosives Safety Organization (PESO) - IAC Workshop on Safety

July 19, 2008, was a red letter day in the Indian Auto LP Gas Industry. About 100 delegates, representing all ALPG dispensing companies, all type approval holders, all approved ALDS installers and also most of the ALPG/ALDS equipment manufacturers attended the first ever PESO-IAC Workshop on "Safety in ALPG Installation and Operations".

All senior officials of PESO, including the Chief Controller, Shri Ajai Nigam, actively participated in the workshop, during which many critical issues relating to ALPG marketers, ALDS installers and the ALPG Kit Industry were discussed. PESO highlighted threadbare the concerns that they had particularly in the area connected to ALDS installations. With a very positive approach of PESO, this conference can be termed as a historic day in the Indian Auto LPG Industry. Consequent to the various issues raised in the workshop, PESO asked IAC, having participation of all ALPG industry members, to discuss threadbare the issues raised, and make appropriate recommendations to PESO. # CRACKDOWN BY AUTHORITIES ON ILLEGAL TRANSFER OF DOMESTIC LPG FOR AUTOMOBILE USE

Auto LPG industry has been severely impacted by the increasing illegal use of domestic LPG as an auto fuel, due to its easy availability at almost half the price of ALPG. We all know use of domestic LPG as fuel is not only illegal and a punishable offence, but also harmful to the vehicle engine. Hence it becomes imperative on the part of ALPG industry to make all efforts in creating awareness for the benefit of our customers.

The Auto LPG industry recently came together along with Government authorities in a drive against the use of "Red Cylinders". The campaigns conducted in different parts of the country were well co-ordinated and very effective.

Industry members met and planned a series of activities required. Communication material was designed to create awareness about the harmful and illegal aspects of "Red cylinder" usage for the purpose of automotive fuel. This

included hoardings, leaflets and newspaper inserts.

The next step was to collect data pertaining to all the illegal establishments who perpetuate or enable use of "Red" cylinders. This included list of unauthorized Retrofitters, suppliers of domestic LPG cylinders, suppliers of transfer pumps and intermediaries.

Subsequently the ALPG industry personnel made a representation to the District Administration which included the District collector, Police, Transport and department of food and supplies. The Coalition team shared the data of illegal establishments with the authorities and requested them to take appropriate action.

Designs of the various communication collaterals were shown to the authorities for seeking their approval. Subsequently the hoardings were put up at vantage points in the city and leaflets were distributed.

This was followed by raids by the Government Authorities at most of the illegal establishments. The raids resulted in the seizure of Red Cylinders and refilling pumps/ equipment.



- 1. Sangamner town in Ahmednagar District of Maharashtra: The raid was conducted on 30.07.08. Seizure of Rs.1.25 lakhs worth of equipment & Red cylinders.
- 2. Miraj town in Sangli District of Maharashtra: Raid conducted on 01.08.08. Seizure of 16 Red Cylinders & arrested the Illegal Refilling station operator.
- 3. Namakkal in Tamilnadu: Raid was conducted on 04.08.08. Govt. authorities have seized 27 Domestic cylinders and 6 Transfer pumps with electric motors in 2 places in a single stretch (Mohanur Road), within 2 hours time.

All the above three locations, the raids were accompanied by media personnel who responded well and ensured proper coverage in the Local News papers on the subsequent days.

The above efforts by the Industry coalition has not only helped create awareness among the customers, but also resulted in significant increase in sales at all the ALPG fuelling stations in the respective locations.







Madurai, the city of Goddess Meenakshi – situated on the banks of the river Vaigai, hub of commercial activities of southern Tamilnadu, is one of the oldest cities in India.

The city has been witness to many important political activities in independent India that has changed the course of the politics in Tamilnadu with its visitors list including Marco Polo, who visited this city in 1293 AD. First thing that comes to a person's mind, when you mention the word Madurai is the Meenakshi Temple. The Temple has become almost synonymous with the place. This is Madurai's most famous landmark.

Madurai has an area of 22 Sq. Km. and population of around 16 lacs. Major industrial activities are Automobile, Textile, Food Processing, Rubber, Hotel & Travel Industry.

The city currently has 6 Auto LPG outlets.

More than 80 % Autos & 60% Petrol Cars are running by Auto LPG and conversion continues at a fast rate owing to the economic & environmental benefits of this fuel.

Almost 15 Retrofitters are active in the market and doing conversion at the rate of 230 kits per month. Awareness among the business people and professionals is very high.

# Message from District Collector, Sh. Jawahar S.S. on Auto LPG

"Controlling emissions is very critical to maintain the city in general and the Temple in particular. To this effect the district administration has been propagating the use of clean fuels like Auto LPG. Madurai is the 1st city in Tamilnadu, after Chennai, to provide ALPG to its citizens. We are happy that there are 6 ALPG stations in the city and the consumption levels have also gone upto around 22-25 kl / day and around 20% of the vehicles consuming petrol have converted to this clean fuel.

We are also constantly taking efforts to encourage use of this environment friendly fuel by way of conversion of vehicles, expediting issue of No objection for setting up ALPG stations and taking appropriate action to prevent misuse of detachable cylinders in the vehicles.

The district administration whole heartedly supports the conversion activities because we want to make Madurai, a GREEN CITY."

"This is the future business for Petroleum dealers as CNG may not be available in Southern Tamilnadu in the near future. Initial reluctance on using Auto LPG is gone among the customers and they are interested to use this rather than Petrol" RIL ALPG Dealer, Mr.R.Sekkappan.

"Auto LPG is a high profit business and unlike other petroleum products, the erosion on profits by means of product loss is almost nil, in case of Auto LPG." Mr.S.Senthil Raja, ALPG Dealer

"Day by day the conversion rate is on upward trend. In the past, only customers from the lower income segment like Taxi Owners/ Auto Owners/Small Workshop/Small Businessmen were using Auto LPG, but now even High Income Group Professionals have started using Auto LPG. There might be a slack in the trend because of recent price hike in Auto LPG as the price difference between Auto LPG and Petrol has reduced considerably." "In comparison to petrol, the operational cost of Auto LPG is lower which helps us to increase our margin considerably. In competitive business, we need to calculate each paise. So Auto LPG is inevitable for our business." K.Nagarajan, Auto Driver

"Auto LPG is a gift for our cab s' business. Almost all the Omnis in the city are being powered by this Green fuel only. But regular increase in price is very much affecting their revenues as they are not in position to revise their contract rate on regular basis" B. Mohan, Owner, Maruti Omni.




Booklet on Safe Practices / Checklist for LPG Operated Vehicles:

# All India ALDS Directory:

There are more than 600 Auto LPG dispensing stations (ALDS) covering more than 250 towns and cities in India. Need was felt to have a comprehensive Industry ALDS directory giving state wise ALDS addresses for the convenience of motorists using Auto LPG. The same was compiled and printed by IAC in the form of a directory. The Directory was released by Sh. Ajai Nigam, Chief Controller of Explosive on 19th July 2008 during the PESO –IAC Workshop on Safety in Nagpur.

10,000 copies of the ALDS directory have been printed and arrangements have been made to send the same to all ALDS in India for distribution to the ALPG customers, Retrofitment centres and vehicle showrooms.



# Auto LPG Dispensing System & Calibration — Training Program for officials of Legal Metrology at FCRI-Palakkad.

Seminar on Inspection and Safety:

During IAC's meeting with Director – Legal Metrology, Sh. R. Mathurbootham, we had expressed desire to be associated with any training program they wished to conduct on Auto LPG.

The opportunity came when Fluid Control Research Institute (FCRI) extended invitation to IAC to conduct a session on "Auto LPG Dispensing System and Calibration" for Officials of Legal Metrology Dept.

Mr. John Joseph, President IAC & Sr. VP- RIL and Sh. Krishnamurthi Tadipatri, GM-RIL were present to take the sessions on 14th and 28th July '08, at FCRI's campus in Palakkad (Kerala) for about 60 officers of legal Metrology who came from across the country. Each training program comprised 2 ½ hours presentation and interactive session on Dispenser calibration followed by 3½ hours practical demonstration at RIL's Auto LPG dispensing station in Palakkad.

FCRI Officials expressed their thanks to IAC for the insight/ knowledge imparted towards Auto LPG which is a relatively new field in India.



#### **Domestic LPG Vs Auto LPG Leaflet:**

Presently the Auto LPG industry is battling with the widespread menace of diversion of cooking gas cylinder for automotive use. This is not only illegal but also unsafe and results in huge losses to the Government exchequer.

As one of the initiative taken by IAC to curb the diversion activity, it has designed a comprehensive leaflet explaining the ill effects of using domestic LPG in vehicles. It is proposed to print thousands of these leaflets and distribute the same to all LPG vehicle owners, retrofitters, OEM showrooms across the ALPG markets in India.

### Bajaj Platina - 2-W ALPG Kit

Bajaj has recently launched Auto LPG Bike (Platina) in Gujarat. The Kit is supplied by Vanaz. The LPG cylinder is well fitted and camouflaged in the petrol tank area itself and not visible from outside. It has thus addressed the problem with retrofitted 2-W bikes where the tank is mounted on the rear carriage of the bike thus marring its aesthetics.

Bajaj Platina is a dual fuel bike with ALPG WC (water capacity) of 4.5 ltrs. while Petrol capacity is 1.25 ltrs. It is priced around Rs. 45,000/- which is Rs. 5000/- more than Petrol Platina. The bike performs satisfactorily on the power and mileage front. There is a good demand for the bike in Gujarat and there is some waiting period for the customers.



#### MUMBAI MARATHON AD.

The Standard Chartered Mumbai Marathon (SCMM) is a mega sporting event. Each year, it attracts more than 30,000 participants from across the globe. The IAC contingent has been regularly participating in this annual sporting carnival for the past three years, running for the cause of Clean & Green India. SCMM provides IAC with a platform to promote itself and the cause for which it stands for.

The press ad. was released on 19th Jan. 2008, in DNA Mumbai a day prior to the Marathon. RIL who is one of the founder members of IAC sponsored the ad.



## **GUJARAT PRESS ADS.**

The CNG lobby in the State of Gujarat had launched a propaganda against Auto LPG during the first half of 2008. To make the position of Auto LPG as a fuel amply clear, IAC decided to come up with Press advertisements in local dailies of Gujarat.

The ad. as you see, talks about inherent advantages of Auto LPG over CNG, thus facilitating car owners to take an informed decision while converting to alternate fuel. Two ads. were released on 29<sup>th</sup> July 2008, one in Gujarat Samachar, and other in Sandesh.

# Campaign against use of Domestic LPG for Automotive purpose in Namakkal.

To curb illegal transfer of Domestic LPG for automobile use, IAC along with the active support of District Administration of Namakkal launched a social awareness campaign. Billboards and posters were put up at strategic location in the town; advertisements in local cable were also flashed. The communication was designed in such a way, so as to deter people from indulging in the illegal and hazardous activity of Gas transfer.
